Record date is the day that determines which shareholders are entitled to receive the capital gain distribution. **Ex-dividend (Ex-Date)** date is the first day on which a fund is traded that the buyer is not entitled to receive the distribution. The **payable date** is the day on which a declared distribution is paid to the shareholders of record. **Re-invest NAV** date is the date on which an investment's dividend or capital gains income is reinvested, if requested by the shareholder, to purchase additional shares.
