

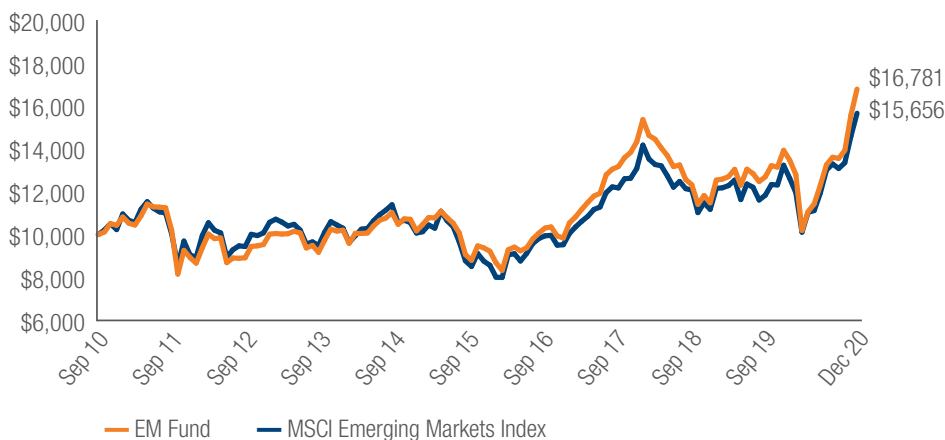
# Emerging Markets Fund

## Investment Approach

The Fund seeks to achieve long-term capital growth by investing in equity securities in the emerging markets.

- The Fund invests in leading companies that can maintain, or achieve in the future, a dominant position within their respective market.
- The Fund's investment strategy is tailored to the fast-growth and dynamic environment of the emerging markets.
- The Fund's investment strategy aims to identify early winners in growing industries, where entrepreneurship can produce long-term global competitiveness.
- Mirae Asset applies extensive bottom-up research methods in a team-based setting to identify investment opportunities.

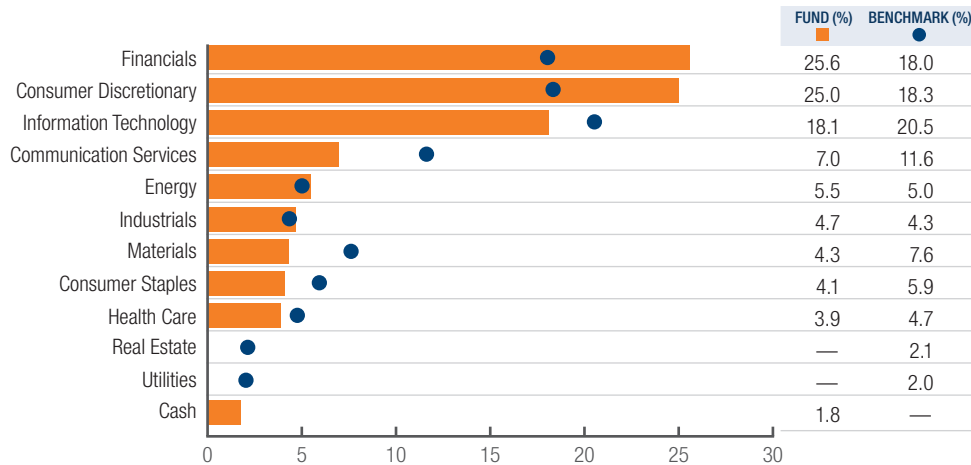

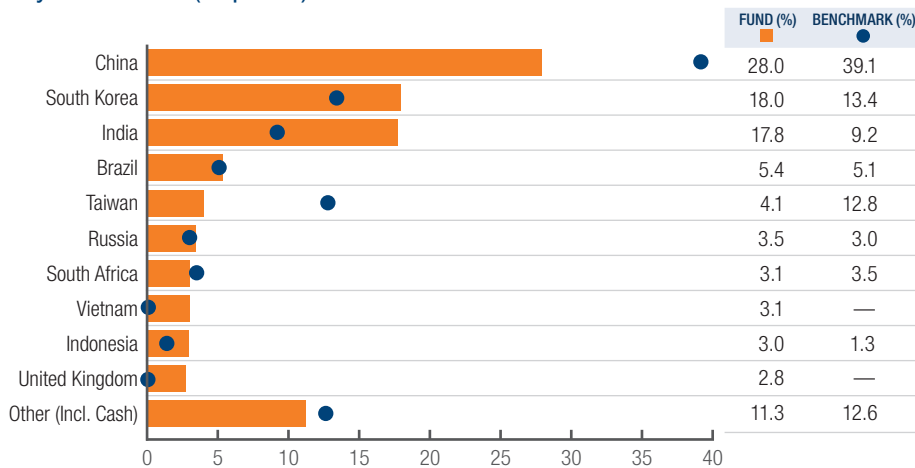

It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10-year (if applicable) Morningstar Rating metrics. The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.

<sup>2</sup>The **MSCI Emerging Markets NR Index** is a free float-adjusted market capitalization index that is designed to measure equity market performance in the global emerging markets.
